No more receipts to submit and successful transactions are deemed compliant automatically. The card also features a high-value discount program for vendors in your proximity.

# Eziway's one-card solution

Eziway's all-in-one Salary Packaging Card gives employees access to their pre-tax funds at the point of sale when paying for two popular benefits- Living Expenses and Entertainment Benefits. This is a leap forward in convenience:

- Only carry one card to pay for both expenses
- Make contactless and/or PIN transactions at eftpos terminals
- There is no need to hold and submit evidence of expenses for reimbursement
- All successful transactions are deemed automatically compliant
- The card is ATO approved

When you make a transaction, the vendor's merchant code directs the charge to the appropriate account. You don't have to nominate an account and live card balances can be checked at the point of sale using the MyEziwayAccount App (the App).

## What you need to do

Order your all-in-one Salary Packaging Card online or call Eziway and we will order one for you. Add the Living Expenses Benefit and the Entertainment Benefit to your packaging arrangement and accounts will be created for each. Your card will be automatically linked to both accounts.

Nominate what pre-tax funds you want loaded into the accounts each pay inline with your cap limit. Funds will accumulate until expensed. Card funds should be expensed prior to the end of each FBT period (31 March) because legacy funds will be rolled over into the next FBT period and deducted from that year's annual cap.

## It's worth noting

- You must activate your card online or via the App
- You can change your PIN via the Eziway Website Portal and/or the App
- Your card will be cancelled immediately upon termination of employment or Salary Packaging account, any remaining funds will be returned to Payroll to be taxed and returned to you
- Transactions over \$200 require a PIN. In these cases select the 'Credit' option
- You can pay for eligible bills with the card using the 'Pay by credit card' option
- Lost or stolen cards can be reported on the App.

## What you cannot do

- Cash withdrawals cannot be made from the card
- Funds on the card cannot be transferred to other cards or bank accounts
- BPAY payments are not supported
- Recurring payments (Direct Debits) are not supported
- the card can only be used for entertainment benefits and living expenses
