# What can I Salary Package?

The below information is of generic nature and may vary according to your Employers salary packaging policy.

## Capped Living Expenses

The annual cap limits of \$15,900 (PBI Charites) or \$9,010 (Public Health) apply within a single Fringe Benefit Tax Year – 1 April to 31 March.

The capped Living expenses include the below items for your consideration:



### Fixed regular commitment payments

Mortgage, rent, personal loans and credit cards repayments.



### Everyday living expenses

Such as groceries, fuel and general bills.

## Meal Entertainment / Accommodation and Venue Hire

Over and the above the annual capped limits of \$15,900 (PBI Charites) or \$9,010 (Public Health) you can package a further \$2,649 towards entertainment by way of sit-down dining, holiday accommodation and the hire of a venue for a special function.



### Meal Entertainment

Sit down meals at pubs, bistros and restaurants.



### Venue Hire

Venue hire costs for functions including catered food and drinks.
